Take I-17 North approx. 26 miles (34 minutes) from downtown Phoenix to exit 223B. Merge onto AZ-74 (Carefree Hwy.) west toward Wickenburg.

Drive 8.6 miles and turn right onto N 87th Ave/N Pleasant Harbor Blvd.

If you are on AZ-74 and reach Castle Hot Springs Rd, you've gone about 3 miles too far.

Drive 2.2 miles to 41402 N. 87th Ave. Your destination is 0.3 miles past W Harbor Blvd. If you reach the end of N. 87th Ave. you've gone 0.3 miles too far.
